Summary

The Vessel Operator of the Harbor Pier is a temporary part time position. The Vessel Operator is completely in charge of the operation of the vessel, which means he or she must accomplish a myriad of tasks. Exceptional knowledge of coastal piloting and the Trinidad Harbor is preferred. Captains must be able to make landings alongside docks and other vessels in all weathers. Attention to detail is imperative. A Merchant Mariners License, OUPV (six-pack), or greater, is required.

Essential Duties and Responsibilities include the following:

- Operates a power-driven vessel in the Trinidad Harbor and connecting coastal waters.
- Advises interested public on harbor, safety, vessel capability, weather conditions, docks, navigation, and other factors, which apply to the vessel's operation and schedule.
- Operates vessel in accordance to regulations
- Prior to daily operation, inspects vessel to ensure efficient and safe operation of vessel and equipment
- Monitors loading and discharging of cargo or passengers
- Performs any various marine duties as needed
- Administers first aid as necessary.
- Maintains standard vessel logs, papers, and reports.
- Assist in removal of debris from harbor and dock.
- Additional duties may be assigned as needed.
